The Birdies for Charity program invites local nonprofits to leverage the excitement of the Cognizant Classic to raise funds for their cause.

HOW IT WORKS

DATES: The program runs from November 5, 2025 through February 25, 2026

PLEDGE & GUESS: Participants who elect to enter via this donation form pledge to donate at least \$20 to the participating charity of their choice. A participant must guess the total number of birdies made by PGA TOUR players during the competitive rounds of Cognizant Classic (February 26 - March 1, 2026).

GRAND PRIZE: One lucky supporter who guesses closest - without going over - to the total number of birdies made during the tournament will win a \$10,000 grand prize! The winner may choose to keep the prize or donate all or a portion of it to a participating charity of their choice, amplifying the impact of their support.

TIEBREAKER: If there is a tie, the winner will be determined by the most accurate guess to a tiebreaker question: How many balls will land in the water at the Bear Trap (Holes 15, 16 & 17)? If multiple ties remain, additional tiebreaker questions will be used until a winner is determined.

BONUS POOL: The tournament will contribute \$100,000 to a bonus pool that will be distributed among participating charities based on their fundraising efforts.
